**I AM AWARE THAT COMBINED TRAINING, JUMPING, TRAIL RIDING, CONDITIONING, POLO AND ALL OTHER FORMS OF EQUESTRIAN ACTIVITIES, INCLUDING THE TEACHING, TRAINING OR COACHING THEREOF CAN BE HAZARDOUS, AND I AM VOLUNTARILY PARTICIPATING IN EQUESTRIAN OR OTHER ACTIVITIES (IE HIKING, DOG WALKING AND/OR TRAINING) WITH THE KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF INJURY OR DEATH.**
